Getinge is committed to reducing our environmental impact both in own operations and across the value chain. We operate with a global perspective on sustainability, guided by the precautionary principle, and in collaboration with our stakeholders. Our key initiatives and principles are:

- Green-house gas emissions: We have committed to the Science-Based Targets initiative and are working towards becoming a net-zero company by 2050. We continually assess our progress and seek innovative solutions to achieve this goal both in own operations (scope 1 & 2) and across the value chain (scope 3 emissions).
- 2. **Resource efficiency:** We continuously work to make our manufacturing processes resource and energy efficient, minimizing risk of pollution, emissions and waste. Our goal is to optimize resource use throughout our operations.
- 3. **Circularity:** We are dedicated to the principles of circularity and actively promote resource efficiency, avoiding hazardous substances and waste in our entire value chain. We work closely with our suppliers and customers to promote circular economy practice where possible.
- 4. Eco-Design: We strive to have a life cycle perspective when developing new products by utilizing LCA methodology. We embrace eco-design principles by incorporating sustainable materials, recyclable components and energy-efficient features into an increasing number of our products. Our aim is to minimize the environmental impact of our products from a life cycle perspective.
- 5. **Business Partners:** We collaborate with our business partners to find alternatives that reduce the environmental impact through-out the value chain. This includes sourcing sustainable materials and adopting efficient production methods.
- 6. **Digital Innovation:** We develop innovative digital solutions that increase efficiency in our own operations and increasingly in our customers' operations, optimizing the use of energy and other resources as well as servicing products to ensure extended lifetime.
- 7. **Product Quality:** By optimizing product quality, we ensure that our products and solutions are reliable, enduring, and resource-efficient enabling low environmental impact.

Management

We have a management system that aligns with the ISO 14001. All manufacturing units have specific certifications. We identify and mitigate risks, as well as evaluate opportunities for improving our environmental performance. We commit to the continuous improvement of the management system in line with evolving standards and best practice to enhance our environmental performance.
