a. Send your AppliSens Sensor order to your sales representative, for the Benelux only, mentioning the promotion code ‘#APPLISENSPROMOTION’

b. During the Promotion Period, purchase a Participating Product directly at Getinge Applikon and provide the Promoter with all required information through email; name of end-user, location and application

Participants will be sent an email to confirm their Claim has been received by the Promoter upon completed entry of a Claim.

Please note that processing of Claims received may take up to seven (7) business days from the date of receipt of the Claim and Participants will be sent an email to confirm whether their Claim has been successfully validated (“**Claim Validation**”).

c. Receive the claim

10. If an email acknowledgement has not been received, it is the Participant’s responsibility to contact the Promoter’s customer service team by email at [customerservice.applikon@getinge.com](mailto:customerservice.applikon@getinge.com) (NL) within seven (7) business days of a Claim being submitted.

11. If a Claim is deemed to have been submitted incorrectly, the Participant will be notified via email and offered the opportunity to provide the required information within seven (7) business days. If no response is received within seven (7) business days of the email, then the Claim shall be marked as invalid.

12. Claims that are incomplete or damaged will be deemed invalid. No responsibility is accepted by the Promoter for lost, delayed or damaged data which occurs during any communication or transmission of Claims.

13. The Promoter reserves the right at its absolute discretion to disqualify Claims which are considered to be incompliant with these Terms and Conditions.

14. Claim of a Promotion Product after the expiry of the Promotion Period will not be eligible for this Promotion. Any request sent after the expiry of the Redemption Period will not be accepted.
